Brokerage customers with a balance greater than \$10,000 are automatically enrolled in the "Optima" program, which gives them additional access to special research services, financial analysis reports, and free telephone support.

The Problem – XYZ Brokerage will experience major scalability problems when faced with administering an overwhelming number of new user accounts. Four systems will be accessed through the web including the Brokerage/Trading System, Brokerage Account Review, and Mortgage Account Review. As a further complication, only a select group of brokerage users will be eligible for the Optima Research Database. Currently, systems administrators have to perform ID administration for 800 brokers in each of the four systems, totaling 3,200 user ID's. Now ID administration must be handled for 800,000 external XYZ Brokerage customers, totaling 3.2 million additional user ID's. Plus the help desk must be able to quickly and accurately entitle its customers based on their Optima status.

The Solution – XYZ Brokerage needs Integrated LDAP Directory Services from OneNetPlus.com to support the varied and challenging demands of its newly expanded user base. An LDAP directory can store ID and password information for use by all four XYZ Brokerage systems.
